Canadian-Lebanese mezzo-soprano, Julie Nesrallah is an internationally renowned singer and broadcaster. She has performed for Prince William and Princess Kate in Ottawa, for Queen Noor in Montreal, and for Princess Haya in Jordan. Miss Nesrallah is the Executive Producer and star of *Carmen on Tap*, a company she created that performs Georges Bizet's opera Carmen as cabaret and has made several recordings with illustrious soloists and ensembles. Miss Nesrallah is a proud recipient of the Queen's Diamond Jubilee Medal.



MRS. ELITE POSSIK BIOCHEMIST & SINGER

Elite is a Lebanese-Canadian biochemist and singer. She received her PhD in biochemistry from McGill University and continues her postdoctoral studies at CrCHUM. On the other hand, she studied oriental singing at the Lebanese National Conservatory, participated in many international musical projects, and released three religious albums. She lives in Montreal since 2011. She directed several events including *Bhebbak Ya Lebnan* under the high patronage of the Lebanese Consulate (*Place des Arts, 2017*) and *Imna Betlemna (Mary Queen of the World Basilica, 2018)* with more than 70 and young and adult choristers and musicians. H.E. FADI ZIADEH Ambassador of lebanon to canada

Ambassador Ziadeh is Holder of a degree in Management and Economics and in International Relations from the *Notre-Dame* University (NDU) in Lebanon. Ambassador Fadi Ziadeh completed also an MMBA at McGill University in Montreal. He started his diplomatic career as an *Attaché* at the Ministry of Foreign Affairs and Emigrants in Lebanon in 1999, and occupied many positions since, such as Consul/ Deputy Head of Mission (DHoM) at the Lebanese Embassy in Abu Dhabi (UAE), First Secretary/Political Councilor at the Lebanese Embassy in Moscow (Russia), *Chargé d'Affaires* at the Lebanese Embassy in Prague, Councilor at the Mission of Lebanon to the United-Nations in New-York. After assuming the post of Consul General in Montreal, ambassador Ziadeh was appointed on the 20<sup>th</sup> of July 2017 as Plenipotentiary and Extraordinary Ambassador of Lebanon to Canada.



## DR. SALIM SFEIR CHAIRMAN-CEO OF THE BANK OF BEIRUT GROUP

Dr. Sfeir's journey has left his personal signature on education, on banking and commerce, on communities and indeed on life. He is the Chairman-CEO of the Bank of Beirut Group since 1993. As a student, he received his B.S.S. degree in Economics from the Université de Montréal and his Masters of Business Administration from the University of Detroit Mercy (UDM). He began his career in Finance with the Bank of Nova Scotia. In 1983 he formed Wedge Bank (M.E.) as General Manager, and in 1987 launched Wedge Bank Switzerland as Chief Executive and Vice Chairman. The turning point came with the Management Buy-In of Bank of Beirut in 1993. Under his leadership, a small, local Bank eventually expanded to 9 countries on 4 continents earning the trademark "Banking Beyond Borders." Today, Bank of Beirut comprises more than 100 branches and strategic business units internationally. A signature theme for Dr. Sfeir has been an unwavering commitment to his Community, including particularly the youth and the Lebanese diaspora. Dr. Sfeir's tireless work has been recognized through many treasured honors internationally, including: Inauguration of the Library of the Pontifical Maronite College in Rome; Knight Commander of the Pontifical Order of Pope Saint Sylvester; Best Banker in the MENA Region and Lifetime Achievement Award-Banker Middle East Magazine; Medal of the National Order of the Cedar conferred by President Michel Suleiman; Honorary President of the Australian Lebanese Chamber of Commerce, Melbourne; Lifetime Achievement Awards for his contribution to the LDE in Johannesburg, Beirut, New York, Sydney, Las Vegas and Paris conferred on him by H.E. Gebran Bassil; with countless additional honors and awards bestowed upon him.



### H.E. FAYÇAL EL KHOURY MEMBER OF PARLIAMENT FOR THE RIGING OF LAVAL-LES-ÎLES PRESIDENT OF CANADA-LEBANON FRIENDSHIP GROUP

Born in Charbila, Lebanon, MP El-Khoury is a poet and has lived in Canada since 1976. A graduate in civil engineering from Concordia University, he was elected in 2015 to the House of Commons. He is a member of the Standing Joint Committee for the Scrutiny of Regulations and Chairman of the Canada-Lebanon Friendship Parliamentary Group. He is also a member of the Canadian Delegation to the Parliamentary Assembly of the Organization for Security and Co-operation in Europe, a member of the Canada-France and Canada-Europe Inter-parliamentary Associations. He is a member of several interparliamentary groups, including Canada-France, Canada-United States and Canada-Italy. Finally, he represents Canada at the Assemblée parlementaire de la Francophonie and the Commonwealth Parliamentary Association.



## MR. MARWAN HAYEK Chairman & ceo of alfa

Marwan Hayek is a telecom veteran and award-winning executive with over 23 years of international career. He is currently the Chairman and CEO of Alfa. Since joining Orascom Telecom Holding in 1999, Mr. Hayek has enabled over 120 million users to benefit from mobile services. PUBLIC RELATIONS CONSULTANT, SPEAKER AUTHOR, REPORTER

Lamia was a Commentator on Radio-Canada radio, had a weekly column in *L'Express* and writes regularly for magazines. An active speaker, her TEDx talk reached 26,900 viewers. 
